**RESOLUTION NO. 07102504**

**ADOPTING LAKE COUNTY PLANNING COMMISSION'S  
ORDINANCE AMENDMENTS (PCR-07-021)**

**WHEREAS**, on October 15, 2007 the Lake County Planning Commission conducted a public hearing regarding the proposed changes to the ordinance; and

**WHEREAS**, the Lake County Planning Commission has sent their recommendation of approval to the Lake County Board of Commissioners.

**NOW, THEREFORE, BE IT RESOLVED**, the Lake County Board of Commissioners amends Lake County Land Use Ordinance Number 12, Section 25 as follows:

Section 25.07 (H)

- 1) Intent and Purpose: The placement of towers over 35 feet in height requires approval through a Conditional Use Permit and if over ~~400~~ 199 feet in height, also requires a height variance. When an application for a tower in excess of ~~400~~ 199 feet in height is received, a joint Planning Commission/Board of Adjustment meeting shall be convened. Because of the nature of public notice required for towers over ~~400~~ 199 feet, the filing fee shall represent the sum of the Conditional Use and Variance application fees.

Section 25.07 (H)(4)

- b) Fencing: The tower facility shall be protected by a perimeter security fence six (6) feet or greater in height to prohibit access by unauthorized persons. The radius of said perimeter shall be ~~equal to~~ at least one half (1/2) the height of the tower sufficient to contain the tower facility and all support equipment and accessory buildings.

Section 25.07 (H)(5)

- b) Towers on new sites shall be of a self supporting design except that the Planning Commission has the discretion to approve guy wires on personal communication and personal wind turbine towers.

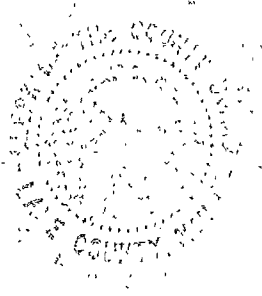


