INTERIM AMENDMENT TO THE LAKE COUNTY LAND USE ORDINANCE,  
ORDINANCE NO. 12 REGARDING SMALLER LOTS  
ON PUBLIC SEWER

WHEREAS, Lake County Ordinance No. 12 amended January 1, 1993 provided that smaller lots might be allowed where public sewer districts existed, and

WHEREAS, it was actually the intention of the Lake County Planning Commission and the County Board to allow this activity only within the non-riparian areas abutting the Knife River Sanitary District, and

WHEREAS, the creation of public sewer districts or the extension of the same is now being contemplated within the county, and

WHEREAS, it is not the intention of the County to encourage rampant development on city-sized lots in rural settings;

RESOLVED, the Lake County Board of County Commissioners directs that Ordinance No. 12 which is already being modified by the Lake County Planning Commission and taken to public hearing be immediately amended as provided in Minnesota Statutes 394, to wit: "public sewer districts" wherever found in the Ordinance be changed to "the Knife River Sanitary District";

RESOLVED FURTHER, that this interim action by the Board be noted on the record copy of Ordinance No. 12 filed with the Lake County Recorder effective this date.

Commissioner Hahn moved the adoption of the foregoing resolution and the same was declared adopted upon unanimous yea vote of all members present.

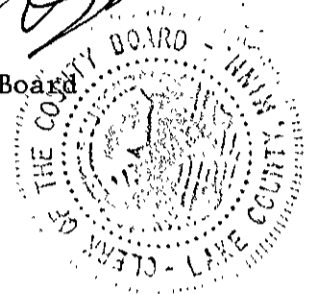
