Regular Meeting of the Board of Supervisors

Thursday, August, 9 noon 408 1st Avenue, Two Harbors, MN 55616

• Call to Order: The meeting was called to order at 12:12 PM by Chair Todd Ronning.

- Agenda: Motion by Haus and seconded by Brodigan to approve the agenda with additions. Affirmative: Ronning, Haus, Omarzu, Sagen, Brodigan. Abstain: None. Carried.
- Minutes: Motion by Omarzu and seconded by Sagen to approve the minutes for July 12, 2018 meeting as printed. Affirmative: Ronning, Haus, Omarzu, Sagen, Brodigan. Abstain: None. Carried.
- Financial and administrative reports:
- Treasurers Report: Motion by Brodigan and seconded by Omarzu to approve the treasures report as presented. Affirmative: Ronning, Haus, Omarzu, Sagen, Brodigan. Abstain: None. Carried.

Audit will take place on September 19

- Guest Updates:
- NRCS Report: Jon Sellnow reported that they are still waiting on funding to fund Eligible contracts. They have a new State Conservationist. The three-year \$400,235 grant agreement was approved to utilize existing capacity and obtain additional capacity.
- District Manager:
- Cost-Share: Motion by Haus and seconded by Brodigan to approve and sign the Ion Cost -share contract for \$1000. Affirmative: Ronning, Haus, Omarzu, Sagen, Brodigan. Abstain: None. Carried.
- After discussion it was decided to table the Spies Cost Share contract request until we have more information.
- Passe gave an update on the Beaver River project. The bids came in over budget. Stantec was able to work
 with the contract to reduce the total amount to \$335,000. Some of the planting will be done by our Office
 possible using some of our crew days and working with the City of Silver Bay. The Silver Bay Council will be
 approving the bid at their meeting on Monday August 13th.
- Cost-Share: Motion by Sagen and seconded by Haus to approve and sign the City of Silver Bay Cost-Share Voucher for \$9,188.25 for Stantec Invoice on the Beaver River Project. Affirmative: Ronning, Haus, Omarzu, Sagen, Brodigan. Abstain: None. Carried.
- The budget request for Lake County was sent out for review we will ask for the full amount that would be matched by the State. \$52,410 and up to \$18,200 which would be matched by the state. Motion by Sagen and seconded by Omarzu to approve the 2019 Budget request to the County. Affirmative: Ronning, Haus, Omarzu, Sagen, Brodigan. Abstain: None. Carried.

- We will again have a booth at the fair. They didn't send out reminders, but we got the application on line and sent in our request.
- The Board was informed about the fact that we are a drop off/pick up site for RMB labs for well testing kits. We have promoted it on our website and facebook page.

Staff Report: Zach Stewart did a presentation on the E.coli project. The grant will start on September 1st. Zach has worked with the grant manager to revise the budget and finalize the agreement.

Zach offered a proposal to the Board to extend his employment until the end of the E.coli grant reporting requirements. Staff were asked to leave the room at 2:29 and returned at 3. Motion by Haus and seconded by Brodigan to approve the employment of Zach Stewart under the terms of the proposal starting September 1, 2018 and ending February 1, 2020. Affirmative: Ronning, Haus, Omarzu, Sagen, Brodigan. Abstain: None. Carried. Supervisor Committee Reports and Concerns:

Audit Committee: Motion by Sagen and seconded by Brodigan to approve the Audit Committee signed 19 Checks and 12 direct payments for a total of \$48,597.01. Affirmative: Ronning, Haus, Omarzu, Brodigan, Sagen. Abstain: None. Carried.

RC&D: Ronning attended and they were updated on the River Conference this fall. We may have up to five staff or supervisors attend the tour and barbeque on Sunday night at the cost of the meal.

Waste Treatment plant: Ronning also stated that he talked with Luke Heitila and he offered a tour of the Waste Water Treatment Plant. We will add it to the Staff meeting agenda to see who would be interested in a tour and a time will be set to do this.

Annual Area III meeting September 20th in Mt Iron: The deadline to register is Sept 7th. **Motion by Omarzu and seconded by Haus to approve up to 5 staff or Supervisors to attend at a cost of \$15 per person. Affirmative: Ronning, Haus, Omarzu, Sagen, Brodigan. Abstain: None. Carried.** Haus, Sagen and Tucker will plan to attend, others who wish to should contact Karen.

Property Owner's Resource Guide: Smerud stated that this is a part of the Waterplan and that it is in the plan to update it. All Supervisors were encouraged to review a copy and bring some changes to the September meeting. Smerud stated that we could update the digital copy for now while the complete update will be probably handled by the Waterplan Committee. She will investigate the cost of printing, Tucker will investigate how many boxes we still have.

Service Agreement with the University for lab costs. It was pointed out that the date should be changed to September 1st. Motion by Omarzu and seconded by Brodigan to approve and sign the agreement pending the date change: Ronning, Haus, Omarzu, Sagen, Brodigan. Abstain: None. Carried.



E. coli Source Investigation (Skunk Creek and Burlington Bay)

- Compiled and analyzed preliminary 2018 E. coli data


AIS and Watercraft Inspections
