- District Manager's Report: Schutte has been working on the work plans for the new grants including
 Timber Improvement, Storm water Assessment and Local Capacity. Motion by Haus and seconded by

 None. Carried. Schutte reviewed his report. Motion by Haus and seconded by Omarzu to approve
 submitting an application to Sustain Our Great Lakes for sediment and e. coli reduction efforts in Skunk

Creek. Affirmative: Ronning, Brodigan, Haus, Omarzu. Abstain: None. Carried. After review by the personnel committee, Courtney Olson's position as Lake SWCD GIS Specialist will be increased to full time. Motion by Brodigan and seconded by Omarzu to approve the offer letter. Affirmative: Ronning, Brodigan, Haus, Omarzu. Abstain: None. Carried. Motion by Omarzu and seconded by Haus to approve and sign the final financial reports for Buffer, Conservation Delivery and 2015 Cost Share with a repayment of \$244 for unused funds on the 2015 Cost Share. Affirmative: Ronning, Brodigan, Haus, Omarzu. Abstain: None. Carried. Motion by Brodigan and seconded by Haus to sign and approve the increased AIS Contract with Lake County for \$80,000. Affirmative: Ronning, Brodigan, Haus, Omarzu. Abstain: None. Carried. Motion by Haus and seconded by Brodigan to approve the \$2,155.81 partial payment to Silver Bay for Engineering costs. Affirmative: Ronning, Brodigan, Haus, Omarzu. Abstain: None. Carried. Motion by Omarzu and seconded by Haus to sign the CCMI crew contract, to be paid via the Forest Stand Improvement CWF grant that was awarded. Affirmative: Ronning, Brodigan, Haus, Omarzu. Abstain: None. Carried. Motion by Haus and seconded by Brodigan to approve the printer contract with Metro Sales, INC for 60 months at \$117.82 per month plus costs per-sheet. Affirmative: Ronning, Brodigan, Haus, Omarzu. Abstain: None. Carried. This will include all maintenance fees and ink costs. Schutte is taking the lead on an application for a 1W1P for the Rainy River Headwaters. We will plan to have a grand opening at our new office in June.

- Rainy River Coordinator: Passe reviewed his report
 - Darren Lilja was introduced to the Board and he updated the Board on his work with Ely public school students with a cyanoscope to assess sample for the presence of cyanobacteria. We are working on a change order on the RR/Cloquet grant to used money left over after the Sonde purchase to get our own cyanoscopes to work with students in Ely and Two Harbors/Silver Bay.
- Outreach Coordinator: Nelson's report was reviewed.
- **Conservation Technician:** Byrns has attended several trainings and shared some of the highlights. He gave an update on his forestry work and Engineering.
- **GIS Technician:** Olson shared a map and the status of the Culvert inventory. She anticipates being done with data clean up in the next couple of weeks.
- AIS Coordinator: Sonja Smerud was introduced to the board and she updated on the projects she has started working on. Motion by Haus and seconded by Brodigan to approve the postings for contracted Summer help for the AIS Ambassador program. Affirmative: Ronning, Brodigan, Haus, Omarzu. Abstain: None. Carried.
- BWSR: Erin Loeffler from BWSR introduced herself to the new Board members. She explained a new process for auditing any grants over \$50,000. BWSR will be assessing the risk factor of the grant, and will be reviewing documents on-site. Districts have until July 1st to add anything to the Buffer Maps. SWCD will be meeting with County staff to discuss additional waterways to include on the map; SWCD staff will have a motion to the Board prior to the July meeting to state additions or state that there are no additions. No new additions are anticipated in our County.

Rainy River Citizen Engagement

- MPCA Advanced Citizen Lake Monitoring Program
 - o Adding Browns and/or Cedar Lake to the program for 2017
- Ely Community Resource AIS monitoring project
 - o Kicking off a new winter project aimed at characterizing the current plankton community in Shagawa and Fall Lakes to see how that changes as Spiny Waterflea colonize in the years to come. Still working out the details with ECR staff, but will be exposing several students per week to AIS/plankton sampling protocols, laboratory techniques, microscope use, and dichotomous key use.
 - Planning to use the materials included in the "CyanoScope" program kit (\$600) for this project. Planning to buy a kit or two, but borrowing one from SeaGrant now.
 - The Kit will also be used for its intended purpose during the open water season. (CyanoScope citizen science program through iNaturalists.org.

We are currently customizing existing training materials to NE Minnesota biology and have planned to put on 4 classroom/field trainings in the USFS classroom and on area lakes.

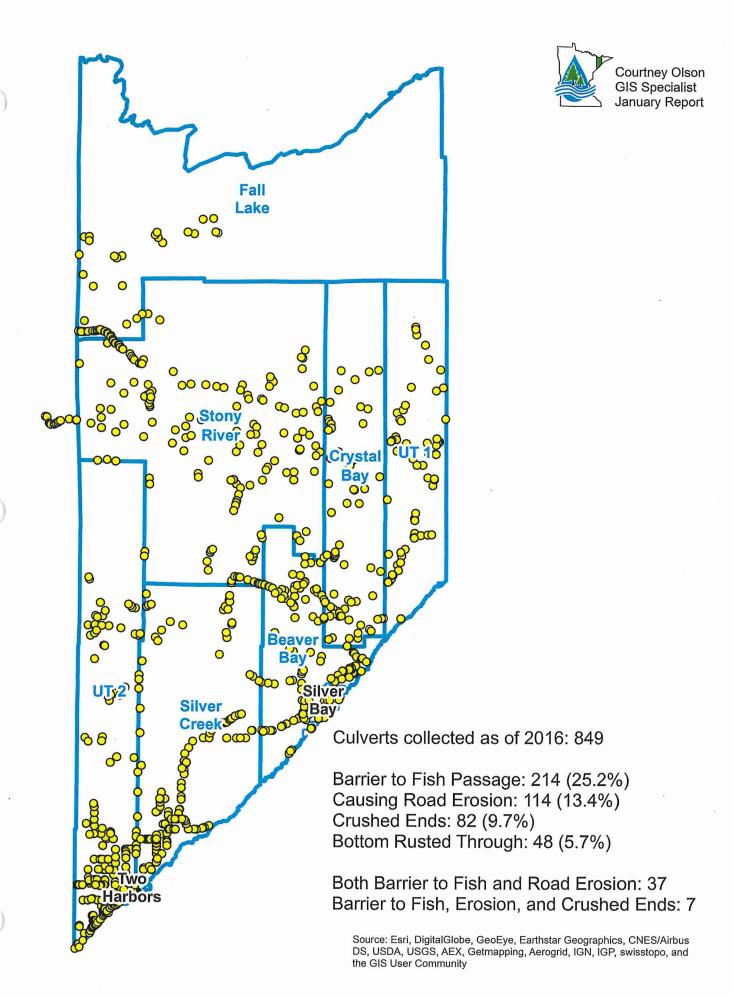

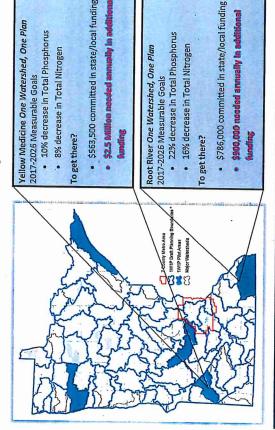
