- District Manager's Report: Schutte stated that buckthorn was found in Beaver Bay, much further up the shore than we thought. He reported that Cove Point and state agencies are interested in helping with the management. Motion by Haus and seconded by Omarzu to approve and sign the CWF agreement for \$185,000 for Stormwater Assessment (\$71,000) and Forest Improvement (\$114,000). Affirmative:




#### **SOGL** Application






