

## Burning Garbage is...

### Unhealthy

Burning garbage, treated lumber, even white paper and cardboard, can cause severe health problems and pollute air, soils and water.

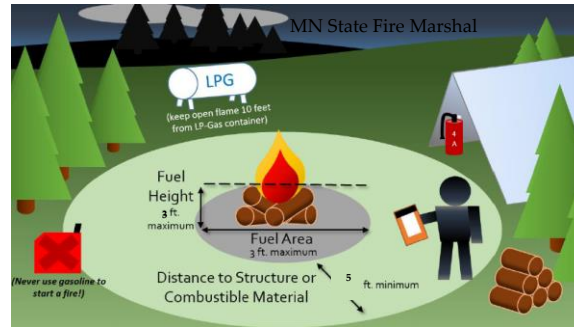
Studies show that due to low burn temperatures and lack of pollution control equipment, smoke from burning household garbage produces levels of dangerous toxins many times higher than a municipal incinerator. Smoke from burning household waste contains acidic gases, heavy metals, and dioxins. **Inhalation of and contact with these materials may cause severe health problems including eye and throat irritation, respiratory problems, and an increased risk of cancer.** Garbage burning is believed to be the largest source of cancer causing dioxin emissions in the US.<sup>1</sup>

### Unsafe

Firefighters respond to over 7000 structure or wildfires each year, and many are started by outdoor debris burning. These fires have injured people, destroyed homes, and set fire to forests and communities. People who start these fires can be held responsible for suppression costs.

### Illegal

Burning garbage and prohibited materials has been illegal in Minnesota since 1969<sup>2</sup>, and prohibited by Lake County ordinance since 1975. Burning garbage illegally is punishable by a fine up to \$10,000 and enforced by the Pollution Control Agency, Conservation Officers, the County Sheriff and City Police Officers.



## What and When Can I Burn?

### What can I burn?

- Vegetative material, such as grass, leaves, brush and unpainted, untreated lumber.

### When can I burn?

- When having a campfire less than 3 ft. in diameter by 3 ft. high, and cleared of all combustibles 5 ft. from the base. A permit is required in Two Harbors and Silver Bay.
- When using a grill, camp stove, or other device designed for cooking or heating.
- When you have a burning permit from a DNR Forester, municipal fire chief, fire warden, or Online Burning Permit service.
- When there is continuous snow cover 3 inches deep or more surrounding the burn area, no burning permit is needed.
- When you burn at night in an approved burner, between 6:00 pm and 8:00 am. During the day, you will need a permit.

## What and When Can't I Burn?

### What Materials Can't I Burn?

- Garbage - discarded material from food handling and consumption
- Construction or demolition debris, including, but not limited to, composite board, tar paper, treated lumber, sheet rock, insulation, wiring, or paint.
- Any structure without appropriate permits. Additional permits are required.
- Plastics
- Oils
- Motor vehicles
- Any chemically-treated materials (including treated lumber)
- Industrial solid waste
- Other materials which produce excessive or noxious smoke, including, but not limited to, tires and railroad ties.
- Rubber
- Electronics
- Hazardous waste

### When can't I burn?

- When there is less than 3 inches of snow, and you don't have a burning permit. (Except campfires, grills & approved burners at night)
- During spring burning restrictions. Before spring green up, dead grass can dry and burn in a matter of hours. Campfires are allowed with restrictions, and variances may be given by DNR personnel.
- During a burning ban. Under extremely dry conditions a "burning ban" may be declared in specific areas of the state. Burning permits are canceled, new permits not issued, and burning in approved burners, campfires, and even smoking outdoors may be prohibited. This is **only** in very severe conditions and is stricter than a burning restriction.
