Tracking of Buffer Compliance Plan

December 6, 2018

Lake County SWCD MONITORING PLAN FOR ANNUAL BUFFER COMPLIANCE REVIEWS

1. COMPLIANCE TRACKING OF ALL PARCELS SUBJECT TO THE BUFFER LAW AT LEAST ONCE EVERY 3 YEARS.

- a. Review of 1/3 parcels each year by Lake County Supervisor District. The review schedule is as follows:
 - i. District 1: 2018, 2021, 2024, etc.
 - ii. District 2: 2019, 2022, 2025, etc.
 - iii. District 3,4,5: 2020,2023,2026, etc.

2. RANDOM SPOT CHECKS (aerial or on-site)

- a. The SWCD may review parcels of emphasis yearly. Examples:
 - i. Previously non-compliant
 - ii. No-till, cover cropped
 - iii. Altered buffer width (alternative practice)
 - iv. Cost-shared funds (year 1,3,9)

3. PROCESS TO HANDLE COMPLIANTS

- a. Upon noticed complaint, SWCD will verify if parcel is on DNR buffer map and reference any existing documentation.
- b. Compliant determination will be evaluated via GIS map and/or site visit with landowner.
- c. If parcel is found out of compliance, SWCD may work with the landowner to come into compliant.
- d. SWCD may provide landowner with technical/financial assistance.
- e. If landowner does not come into compliance by given timeline, a Notification of Noncompliance will be sent to the county/BWSR.
- f. Upon completion, the SWCD may issue a validation of Compliance if requested by landowner.

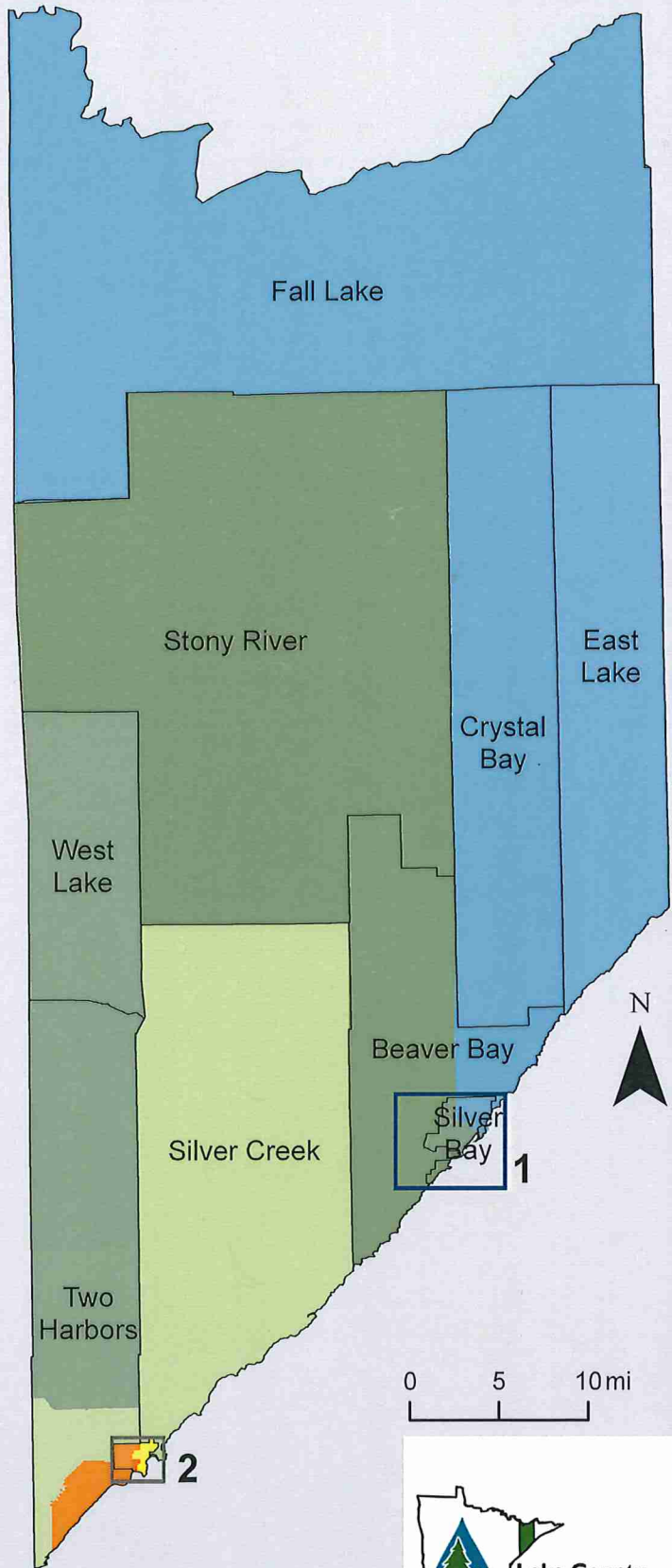
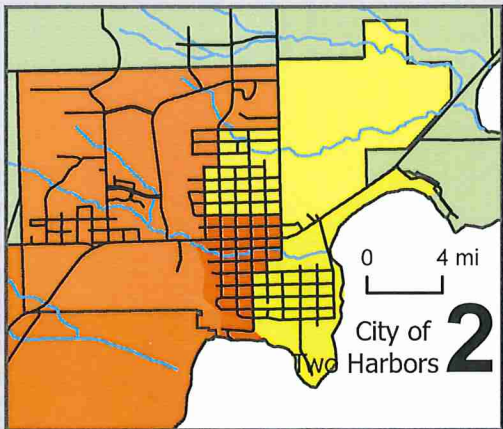
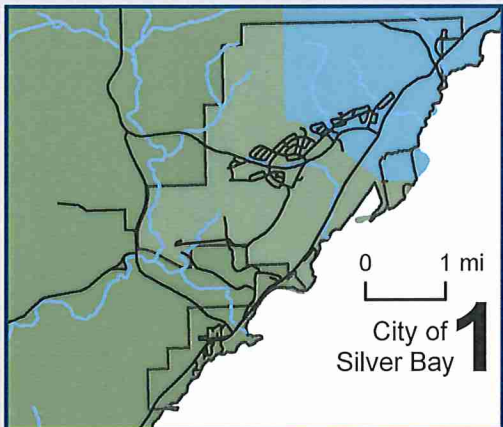
