**POSITION:                   DISPATCHER/JAILER**

The current vacancy is for one full-time male position requiring 12-hour rotating shifts in the Lake County Sheriff's Office.

**SALARY:**                   \$20.71 – \$27.96 per hour

**CLOSING DATE:       Open until filled; initial review May 10, 2022**

Applications must be on official forms. Resumes will be accepted, but not in lieu of an application.

**EXAM:**                    Typing Test

**MINIMUM QUALIFICATIONS:**

High School Diploma or G.E.D. and ability to type 25 wpm with 10 or less errors  
Applicant must be male - BFOQ (bonafide occupational qualification)

**RESPONSIBILITIES:**

Responsible for answering 911 emergency calls and dispatching appropriate personnel; and maintaining safety and security of inmates and a secure jail facility. Responsibilities may include answering emergency calls; tracking status of personnel on response calls; providing emergency information as necessary; conducting the booking process of inmates; performing searches and inspections of facilities and inmates; observing activities in person and through computers in the corrections facilities.

**WORK TEST PERIOD:**

Appointee to the position must successfully complete probationary period per contract.

**BACKGROUND CHECK:**

Applicants selected for appointment must pass a criminal law enforcement background investigation.

**DRUG TESTING:**

Applicants selected for appointment must take and pass a drug test.

**PHYSICAL-MEDICAL STANDARDS:**

Applicants must meet essential physical and psychological requirements of the position.

**EMPLOYMENT ELIGIBILITY VERIFICATION:**

All new employees must complete and sign employment eligibility verification form on the first day of employment. Documentation verifying identity and employment eligibility must be submitted within three days of the first day of employment.
